NEWSLETTER TO RESIDENTS OF BELLE MEADE JUNE 2018

SIDEWALKS ARE COMING TO BELLE MEADE'S HARDING PLACE-CONSTRUCTION IS UNDERWAY!



Sidewalks are under construction for both sides of Harding Place between Belle Meade Blvd. and Lynwood Blvd. This project gained Commissioner approval following a residentdriven effort due to safety concerns on this increasingly busy street. With the dramatic growth of Nashville in recent years, the safety of pedestrians and bikers on Harding Place has declined significantly. Following a traffic study conducted by the Belle Meade Police Department, it was confirmed that nearly 10,000 vehicles pass through Harding Place on any given day, the highest in the City of Belle Meade, aside from Harding Pike. Without a safe shoulder or separation from the road for pedestrians, Harding Place residents are currently forced to share this two-lane road with high vehicular traffic, a danger to the many residents who walk, run, and cycle—often with strollers or dogs—throughout the neighborhood. Sidewalks were an original part of this stretch of historic Harding Place (and a number of other streets in the Belle Meade community) that was envisioned to be a pedestrian link throughout the neighborhood. These new sidewalks will be on both sides of the street, reconnecting the Harding Place neighborhood and adjoining streets. The sidewalks will be similar in style to those located on Lynwood Terrace, respectful of landscaping, driveways, and mailboxes to the extent possible.

Following criteria presented by the Board of Commissioners, the residents of Harding Place diligently pursued and organized their effort, unanimously agreeing to the need for sidewalks. Led by Neighborhood Watch block captain Jackie Bellar, the neighborhood group organized a sidewalk committee in 2016 and over the next two years held planning meetings, discussed options, met with Commissioners individually, and made formal presentations to the Board. Residents also wrote letters to Commissioners, did extensive research, attended Budget & Finance Committee meetings, met with City Staff including Beth Reardon, City Manager and Aspen Collins, Finance Director. While many residents were involved in the effort, some of those taking more active roles, in addition to Jackie, included Bunny Blackburn, Randy Gross, Kristin and Carter Paine, Doris Matthews, Laura Katherine Wood, and Marty and Betty Dickens. In the process, a side benefit was that Harding Place neighbors enjoyed getting to know each other better.

Money was budgeted for sidewalks in the 2017/2018 budget and the project was sent out for contractors to bid. The bid came in at an acceptable price and after initially rejecting it, the Commissioners approved the bid for construction on April 30th. The residents of Harding Place are especially grateful for Commissioner support of this endeavor.

This summer, Harding Place will be a safer place for its residents and for all who live in the City of Belle Meade.

BE AWARE OF THE HARDING PLACE SIDEWALK CONSTRUCTION ZONE

During the day, from 8am to 4pm, one lane of Harding Place traffic will be detoured to Iroquois Avenue. Please avoid this area altogether if possible, and take a different route to your destination. The sidewalk contractor expects to finish this project in 30 days, weather permitting, so we hope the inconvenience to drivers will not be for long!

VIDEO SURVEILLANCE CAMERA PROJECT – UPDATE



Progress on the Surveillance Camera project has been slow but steady. Obtaining approval from NES and ATT for attachments to the utility poles was a tedious process. Once that step was completed, the Commissioners approved for a contrac-

tor to add the electrical service to each pole, and install two decorative metal poles at locations where the NES utility pole was not accessible. NES and Metro Codes inspected the electrical service installations, and have given their approval. In the meantime, Chief Eads has been working the wireless connectivity portion of this project and is about to have that finalized in time for a late June/ early July installation of the cameras on the poles. There will be digital and license plate reader (LPR) cameras at 20 intersections surrounding Belle Meade.

The Commissioners and the Police Department are very happy to see this project finally come to completion. It will bring an enhanced measure of safety to Belle Meade citizens and surrounding areas, as other police departments may also benefit from the crime information we capture on our cameras. Park Smart

May 31, 2018 FOR IMMEDIATE RELEASE A review of stolen vehicle reports in Nashville from Sunday, May 20th through Saturday, May 26th shows that 62% of the automobiles taken (38 of 61) were easy targets because the keys were left inside or made available to thieves. Ten of the 61 vehicles stolen were left running without the driver present. The police department's continuing PARK SMART campaign strongly urges citizens to lock their automobile doors, secure any valuables and REMOVE THE KEYS. Officers also urge citizens to SHOP SMART by not leaving purses or other valuables unattended in shopping carts or in plain view in vehicles, even for a very short time. An unattended purse or wallet is an easy target for a thief.

RECYCLE REMINDERS

The City's trash collection contractor has noted there are high levels of contamination (trash in the recycling mix) in the recycling collections. The requirements by the recycling industry for quality—clean recycling

—are increasing due to new policies implemented by the end markets for recycling materials. Worldwide, the recycling industry has been influenced by stricter regulations on what is acceptable. For instance, China has much stricter limits on the quality and quantity of material it accepts for recycling, having global implications on the industry. To ensure the long-term sustainability of recycling programs, even our small one in Belle Meade, here are a few tools for success to follow to avoid having your entire recycle bag contaminated and disposed of in the landfill.

RECYCLING DO'S	RECYCLING DON'T'S
DO recycle all empty plastic bottles, cans, paper and cardboard.	DON'T include food-soiled items. They turn an entire load of recycle into trash.
DO keep foods and liquids out of recycling.	DON'T add sharp or dangerous materials like needles or electronics—they can cause Injury to workers.
DO keep plastic bags out of recycling – they get tangled in the machinery.	
	DON'T toss "tanglers" like hoses or wires.
	DON'T include bulky items like propane tanks or construction debris.
